



## Committee Interest Application Form

Positions are available to serve on various boards and committees within the Town of McCordsville. Applicants must be residents of the Town of McCordsville.

Town boards and committee functions are as follows:

**The Redevelopment Commission** – This commission looks for ways to provide economic development and redevelopment of the old town center area and other areas of the Town. The Commission consists of five (5) members, with three (3) members appointed by the President of the Town Council and two (2) members appointed by the Town Council. This committee meets periodically.

**Metropolitan Board of Police Commissioners** - The Metropolitan Board of Police Commissioners controls the management of the Town's Police Department. The five-member board may not have more than three members of the same political party. Board members are appointed by the town council and serve staggered terms.

**Advisory Plan Commission** – The Plan Commission has the authority to review, approve, and grant the petitions and permits listed in the McCordsville Zoning Ordinance and Subdivision Control Ordinance. The Plan Commission is a seven (7) member board as prescribed by State Statute (IC 36-7-4-207(b)).

**The Architectural Review Committee** – This committee is responsible for reviewing the architectural standards of developments, both residential and commercial, within the Town to insure the development complies with the regulations of the Town. This committee meets monthly, the third Tuesday of the month.

**The McCordsville Board of Zoning Appeals** – The board's purpose is to conduct hearings and render decisions on appeals, variances, special exceptions or changes of non-conforming uses and to hear other petitions deemed to fall within its purview. The board consists of five (5) members and meets periodically.

**The Parks Board** – This board looks at the feasibility of acquiring, preserving and managing park land within the Town. The board will work to establish a network of greenway corridors that interconnect the community and link the multi-use path systems within the Town, as well as to work with neighboring municipalities to encourage their linking to the McCordsville multi-use trail system. The board also looks at ways to increase recreation and community involvement within the town. The board consists of five (5) members. The board typically meets every other month.
