Runway Blvd Speed Study

New Business

Fence Variance Request at 5518 Wood Spring Lane

Discussion took place on whether the fence needed to be taken down and moved to where it was permitted. Mr. Crider stated they need to meet with the Drainage board.

Mr. Crider made a recommendation to the council to move the fence, and to reconstruct it as permitted, Mr. Gropp seconded, the board voted 3/1. Mr. Jones voted against.

Signal Warrant Analysis - Brookside Pkwy/Emerald Springs & 600 West intersection

Mr. Witsman presented the traffic study for the proposed traffic light. A discussion also took place on the budget for this traffic signal.

Mr. Gropp made a recommendation for the RDC to consider funding for the engineering portion for the signal light, Mr. Crider seconded, the board voted 4/0.





Special Event Request- McCord Pointe

Mr. Gropp presented the special event request. The suggestion was to set up barricades at the major intersections.

Mr. Gropp made a motion to authorize the temporary closing of the main roads on July 4th from 10:30 AM-12:30 PM at their discretion, Mr. Crider seconded, the board voted 4/0.

Discussion took place on the garbage and recycling contract.
